Dear potential campers with disabilities and families,

Disability Services Resource Center (DSRC) provides sponsorships for children and adults who have a disability and want to attend summer camp, whether recreational or therapeutic (one session per year) that are NOT DSRC's Summer Special Needs Enrichment Programs (SSNEPs). Those attending SSNEPs are offered an alternative funding program and it is already extensively reduced because of various grants that are applied to the cost.

Sponsorship amounts are based on how much campers and their families participated in DSRC fundraising events the past two years. Events/opportunities included: the Gift Card Fundraisers, Virtual/Annual Auctions, Calendars by Kids with Disabilities, Tag Days, YES I CAN Drive, Give Local Bay day, and/or assisted with DSRC activities such as yard and garden clean up days, ramp builds, pancake/French toast breakfasts, bringing baked goods for events, etc. If you are new to DSRC and are looking for ways to meet the above requirement, please contact us by email to [dsrbcc@gmail.com](mailto:dsrbcc@gmail.com) or call 989-895-5444.

Camperships will vary from \$100 to \$300 per camper, based on: your participation with DSRC as mentioned above, available funding, and proven financial need. Camp sponsorships will be awarded after attendance at the camp and submission of the report explained in the next paragraph. Campership amounts will be assigned by DSRC's Scholarship Review Committee.

It is imperative that campers and/or families adhere to the conditions of the sponsorship which includes following up with a report of participation at the camp and a thank you note to DSRC. Be sure to also include in the report how you were involved with DSRC's fundraising events or other activities.

If you need a camp application form, please call the camp directly to request one. We do not keep camp applications on hand. Also, please note that you are required to pay a deposit directly to the camp with your camp application.

When you return your completed Financial Aid Application to our office (a 2-page, blank form is included), please tell us if you have paid your deposit to the camp. There is a chance that financial aid funds are also available from the camp itself or through respite funds. Please check with them directly.

The **deadline** for returning the Financial Aid Application is **June 30th each year**. **Applications submitted after that date will only be considered if funding is available.**
